## **RE: Additional Federal Assistance Requested**

Dear New Jersey Congressional Delegation Members,

As the leaders of the Garden State's major business associations, as we move through the current lameduck session and into the next term, we strongly urge you to prioritize additional federal assistance for states. The CARES Act provided key support to New Jersey families and businesses, but many programs have already expired and at the end of 2020 all Coronavirus Relief Funds (CRF) will expire. Without further assistance, New Jersey will struggle to weather the public health and economic crisis in the short-term and face a much slower economic recovery in the long term.

## FEDERAL COVID-19 SUPPORT FOR BUSINESSES REMAINS CRUCIAL:

**Federal State Budget Assistance & General State Support:** We thank you for all your efforts which have channeled restorative CARES Act money to the Garden State during this crisis. While this additional funding will certainly help our struggling business community, New Jersey, like many other states, resorted to drastic measures to account for unprecedented budget shortfalls.

The COVID-19 Emergency Bond Act, which led to \$4.5 billion in borrowing for FY2021, means we could be servicing debt in each and every state budget for decades. With this in mind, we urge you to support legislation such as, or similar to, the bipartisan State and Municipal Assistance for Recovery and Transition (SMART) Act. The SMART Act would allocate \$500 billion in federal funding to state and local governments, which will reduce the need for drastic and damaging fiscal measures in the future. Federal relief, such as that in the SMART Act, could be used for needed relief. This includes more small business grants, childcare, K-12 education, workforce training and money to avoid borrowing and debt service burdens that will crowd out important investments benefiting the people of New Jersey. Additional federal support will also help facilitate distribution of funds to health care providers who did not receive CRF but need assistance to address the care needs of our residents amidst this pandemic.

After the state labor force recovered some of its pandemic decline by July, it fell again in August and September to its lowest level during the pandemic and lowest rate since 1976, decreasing by nearly 240,000 in just two months. There is a strong correlation between the number of businesses that have closed and the number of individuals who have given up looking for work altogether and, thus, are no longer in the labor force. Given the massive decrease in the labor force, the current decrease in the unemployment rate to 6.7% is misleading and should not be celebrated, as it largely reflects the 230,000 NJ residents who have given up. More federal assistance is needed for them.

Finally, Personal Protective Equipment (PPE) is imperative for all residents, regardless of occupation. While our frontline workers need the protection necessary to keep themselves safe while providing essential care and services, PPE has become a part of everyday life no matter what you do. To that end, we urge Congress to work to accelerate production of PPE so that we can keep ourselves, and each other, safe.

Replenishing Unemployment Insurance Trust Fund: We also urge you to support any legislation that would *allocate federal funds to replenish state Unemployment Insurance Trust Funds*. Replenishing the Unemployment Insurance Trust Fund is critical to New Jersey's financial well-being. Since the end of March, over 35% of New Jersey's pre-pandemic workforce (1.7 million people) have filed for unemployment benefits. This historic breakdown in the labor market was reflected in our peak unemployment rate of nearly 17% in June 2020. To put this in perspective, during the Great Recession, our unemployment rate never surpassed 10%. Federal funding of state UI funds could avoid massive payroll tax increases on all employers.

**PPP Reform Is Still Needed:** Small businesses across New Jersey have exhausted their PPP loans attempting to restart our state and local economies. *We continue to urge you to support H.R. 7777/S.* 4117, which would provide loan forgiveness for businesses which borrowed \$150,000 or less if they submitted a one-page attestation to their lender, stating that funds were used properly. Loans of \$150,000 or less make up approximately 87% of all PPP loans, but only 28% of the dollars were awarded. Additionally, the legislation would protect lenders from enforcement action if the borrower's one-page

attestation contained falsehoods. This reform would be crucial, as the number of small businesses that are open according to data from September 29, 2020, is down by 22.7% relative to the beginning of the year.

Additionally, as a result of public health mandates, such as new COVID-19 screening requirements and sanitization standards, businesses are continuing to see their operating costs rise. With this in mind, we continue to urge you to support the reforms in S. 4321, the Continuing Small Business Recovery and Paycheck Protection Program Act, that would provide the hardest hit small businesses access to a second PPP loan, expand eligibility for PPP loans to 501(c)6 organizations, and allow funds to be used for operating expenses including sanitization and PPE. In addition to including 501(c)6 organizations, the 'lobbying' disqualified also needs to be eliminated as it will prevent several important organizations in NJ from receiving assistance due to their lobbying activity.

Finally, we urge that entities, who borrowed over \$2 million, not be required to prove they did not mislead lenders if their financial performance is better in 2020 relative to 2019. Our concern is that this provision will lead to much lower rates of forgiveness for entities. Moreover, it does not make sense to determine a business acted in bad faith in April when the first wave of COVID-19 was creating immense uncertainty nationwide, simply because they wound up having positive financial performance months later.

**Business Safe Harbor/Liability Protection:** Businesses, higher education institutions, and nonprofits which follow all applicable health guidelines need liability protections from COVID-19 related litigation. Entities which continue to take the time to adhere to all relevant state and federal health standards and guidance simply cannot afford to be caught up in a meritless lawsuit. The protections we seek would not protect businesses that operate in bad faith or disregard guidance on reducing the spread of COVID-19. **We urge you to continue to support federal liability protections** so that our businesses can continue to focus on restoring our economy.

Reform for PUA Program Needed: We urge you to consider reforming the Pandemic Unemployment Assistance (PUA) program. PUA has been effective in assisting those who do not typically qualify for Unemployment Insurance (UI) and who are experiencing financial strain through no fault of their own. However, certain eligibility criteria have wrongly excluded some independent contractors, self-employed, and gig workers who were intended to be served by the program. The issue is that some of these workers started working part-time for other businesses during the pandemic as their normal business activity dried up. If their part-time work makes them eligible for regular UI, they automatically become ineligible for PUA since one must be denied regular UI to receive PUA. The biggest issue with this is that the UI benefits individuals are receiving, in coordination with their part-time work, are often far less than the PUA benefits they would receive in coordination with the income they earned through self-employment or gig work.

The current rules for PUA eligibility need to be revised to accommodate this type of situation and we encourage you to support any reforms that are proposed. Ideally, the existing legislation would be amended to allow individuals to collect the benefits they are eligible for under PUA, in relation to the income they earned when they were self-employed or an independent contractor, and then collect any

additional benefits they are eligible for as part-time workers from the regular UI fund up to each state's respective weekly benefit cap. In New Jersey, that cap is \$713/week.

This reform is essential so that those who deserve and need these benefits will be given access. This is crucial at present, but especially important if Congress considers renewing PUA.

## OTHER FEDERAL PRIORITIES TO SUPPORT NEW JERSEY BUSINESSES BEYOND COVID-19:

Outside of the pandemic, but even more important due to the pandemic's devastation of the economy, we want to highlight the importance of continuing to invest in crucial infrastructure during this crisis by urging support for federal funding for the **Gateway Program**. This trans-Hudson tunnel project is crucial to the long-term sustainability of the regional economy in the Northeast United States and should not be delayed any longer.

Also to stimulate the New Jersey economy when we need it most, we ask you to continue to support any tax relief legislation that comes before you, including **eliminating the \$10,000** cap for the State and Local **Tax (SALT) deduction**. Without additional relief for New Jersey's struggling families and businesses, we will never see a strong economy in our state after we recover from the pandemic.
